Describe How this Grant Will Help Address Public Health Needs:

Orosi High School has developed and implemented a Program of Study for a Career Pathway Academy of Heath Sciences that has currently been in existence for 8 Years. Each course is filled with rigor and curriculum that provides them real life applicable skills needed in the realm of health care. This Academy has met the thresholds of "Distinguished Status" under the National Academy Foundation for the past two years. In 2019-2020, COJUSD formed a partnership (MOU) with Kaweah Delta Hospital and the UC Merced Center for Medical Education and Health Services to establish the Central Valley Pipeline Doctor Academy in order to establish a pipeline of health workers to help address the need/shortage of healthcare workers in Tulare County by preparing underrepresented, underprivileged, rural students who are college ready to engage in a career that prepares them to become a physician or essential healthcare worker. Most importantly healthcare workers, who will return to serve the needs of the Central Valley and promote community wellbeing, health equity, and advocacy.

The past 5 years, Orosi High School has collaborated with health industry partners such as Alta Family Health Clinic, United Health Centers, Valley Health Team, Pro PT and Kaweah Delta District Hospital just to name a few to provide students job shadowing and internship experiences to develop and strengthen their knowledge and practice of healthcare skills so that we can collaboratively grow and develop a pipeline of essential healthcare workers that will come back to serve and practice in our local communities.

The funds from this grant will allow us the opportunity to compensate students a monetary stipend of \$510 dollars each to participate in a Work Based Learning Job Shadow or Student Internship experience in the field of health sciences. Students will complete 80-120 hours per internship. In addition, these dollars would help support additional experiences for students to collaborate in various health career conferences and workshops to interact with health professionals and support our efforts in bringing about an awareness and exploration opportunity for students to utilize their communication skills, develop 21st Century skills needed to become productive citizens of the future. These dollars would also be used for conference registration fees, transportation costs and or hotel accommodations.

Describe the Use of the Grant in the Following Areas:

The Geographic Area Served:

Orosi High School is home to approximately 1060 rural under represented students. The student population at Orosi High School has an approximate student makeup of 93.8% Hispanic, 1.3% White, 4.4% Filipino, and .5% other. Approximately 35%% of OHS students are English Language Learners (ELL's). The majority of the high school students come from middle to low socio-economic and educationally disadvantaged homes and 100% are on Free/Reduced School Lunch. Cutler-Orosi Unified School District has approximately 4002 students enrolled at three elementary schools, 1 middle school, 1 Independent Studies School, 1 Alt. Ed HS and 1 Comprehensive High School. Unemployment in Cutler-Orosi is often drastically higher than state and national averages, especially because the availability of agricultural jobs is inconsistent. According to the 2000 U.S. Census, per capita income for the Orosi-Cutler CCD was approximately \$8,176, compared to a national figure of \$21,587. The combined statistics contribute to making Cutler-Orosi the largest unincorporated community in one of the poorest counties in California, and these factors are compounded by educational, linguistic, and other social factors. 55% of adults aged 25 years and older in Cutler-Orosi do not have a high school diploma. Of these, 81% percent have less than a ninth grade education (American Community Survey, 2005-09). Given that many community members are recent immigrants, language and other factors combine with low education levels to affect the extent to which they are able to access social services.

57% of students in the Cutler-Orosi Joint Unified School District are designated English Learners; of these, 98% are Spanish speaking (California Department of Education, 2011). Student ethnic demographics vary little from school to school, and are reflective of the community demographics: of the district's 4,002 students, approximately 94% are Hispanic or Latino, 3.3% are Filipino, 1.9% is White, and the remaining 0.8% is made up of African American and Asian students. The table below details demographic information for the district's students.

These dollars would also be used for conference registration fees, transportation costs and or hotel accommodations that are above and beyond what our current funding sources can pay for and or are allowed. Investing in our current generations of students will ensure we have future heath care workers to care for our older generations.
